Entry fee and Payment: Early bird entry fee: 125 € per competitor applied and paid by

bank till 31st of December 2024

Regular entry fee: 150 € per competitor applied and paid by bank

till 18th of February 2025

Late registration: 200 € per competitor applied and **paid by bank** after 18th of February 2025, in case OC approves the subscription.

Entry fee **paid in cash** – 200 € per applied competitor.

If an athlete registered online through the WT registration system does not take part in the competition for some reason but has not been removed from the list of participants before the deadline (17.02.2025), the team's official must fully (100%) pay his/her entry fee for participation. **The Organizing Committee does not refund entry fees paid.**

All bank transfer payments must be made without deduction of expenses. When the wire transfer is set, mark option "OUR." The sender must pay for any bank transfer costs; otherwise, the team representatives will be charged at the Registration desk.

Applications without a copy of the entry fee transfer will be considered as invalid.

Modification of a category:

Before the deadline (17.02.2025) – Free of charge until 17.02.2025 After the deadline* – 50 € for each modification, paid in cash at the Registration desk.

*Possible **only** before the official weigh-in attempt of the respective athlete.

Each on-site approved additional request for an accreditation card (new or reprinted) or registration of team officials on the top of the allowed quotas will be **charged 30 €**.

Competition Rules: The latest WT-approved Competition Rules & Interpretation will apply.

Protector and Scoring System: KPNP. Electronic socks will be available at a KPNP booth in the venue.

For all Cadets' events – regular electronic headgear will be used – **no face shield will apply**. All competitors must use WT-approved equipment.

Instant Video Replay: ReStrike. Livestream will be provided for all courts.

OVR: Taekoplan SenSoft Automation.

Conditions of participation: All Athletes & Officials must hold a valid 2025 WT Global Licence and must be a member of a National Taekwondo Federation affiliated with the WT. Onsite registration for a WT Global License will be not possible. GL registration must be done in advance.

All contestants have to prove their age and nationality by presenting a national ID or passport at weigh-in, if requested.

Those who are not recognized as adults by law in their own country must submit a passport or identification card along with written consent (liability declaration) of their parents or lawful guardian accepting the participation and all parts of the official invitation.







Method of competition: Single elimination tournament system. Best of three (3) systems. **Contest time:**

- Seniors 2(3) rounds x 2 minutes with 1 minute break
- Juniors and Cadets: 2(3) rounds x 1,5 minute with 1 minute break

The contest time is subject to change by the appointed for the event WT Technical Delegate.

Age Groups:

- Seniors: born in 2008 or earlier (WT G1 ranking)

Juniors: born in 2008, 2009, 2010 (E1 ranking)

Cadets: born in 2011, 2012 and 2013 (E1 ranking)

Athletes born in 2008 could compete in Juniors and Seniors age classes.

Categories:

Seniors Male: -54kg, -58kg, -63kg, -68kg, -74kg, -80kg, -87kg, +87kg; **Seniors Female:** -46kg, -49kg, -53kg, -57kg, -62kg, -67kg, -73kg, +73kg;

Juniors Male: -45kg, -48kg, -51kg, -55kg, -59kg, -63kg, -68kg, -73kg, -78kg, +78kg; **Junior Female:** -42kg, -44kg, -46kg, -49kg, -52kg, -55kg, -59kg, -63kg, -68kg, +68kg; **Cadets Male:** -33kg, -37kg, -41kg, -45kg, -49kg, -53kg, -57kg, -61kg, -65kg, +65kg; **Cadets Female:** -29kg, -33kg, -37kg, -41kg, -44kg, -47kg, -51kg, -55kg, -59kg, +59kg

Competition schedule:

01.03.2025 – All Cadets and Juniors Events 02.03.2025 – All Seniors Events

Seeding: 100% seeding will apply according to the latest available WT (for Seniors) and ETU (for Juniors and Cadets) Rankings will apply.

Recognized brands: Participating contestants are required to wear WT-recognized doboks, belts and WT-recognized protective equipment. The latest version of WT-recognized manufacturers' list is available at the website of WT: http://www.worldtaekwondo.org/wtpartners-wt/recognize.html

Liability: All competitors participate at their own risk. The online registration implies that the competitors agree to assume all responsibility for themselves and to release all other parties from any liability which may directly or indirectly result. The organizer is in no way responsible for any damage caused to a person or their belongings.

Awards: Medals for the places 1 to 3 individual results. Team cups will be awarded to the three best teams in each division. The team ranking is based on the following point system:

- 1. Every gold medal 120 points;
- 2. Every silver medal 50 points;
- 3. Every bronze medal 20 points;
- 4. 1 point per each contestant who entered the competition area after passing the general weigh-in;
- 5. 1 point per each win (win by a bye included)







Coaches: WT Level I Coach certificate or above is mandatory for officiating as a coach at the event. For every five contestants within the same team, one coach is granted free admission, with a maximum of four coaches. Every additional coach above the maximum allowed number should pay 30 € admission. During the registration, the Head of the team or the coach will receive all the team's credentials. Entry at the venue or weigh-in will be possible only by holding an accreditation card. The following accreditations will be provided to team members on request to the OC:

The Trainers will not be allowed to the Field of Play.

Protest: Only the official coach is allowed to protest, immediately after the end of the contest. An amount of € 200 (Euro) will have to be paid for each protest. The decision of the referee chairman is final.

Referees: All referees will be contacted and invited by the Referee Chair of the event. Hotel and Full board accommodation will be provided for the International referees from 28th of February till 3rd of March 2025.

Visa: Teams and individuals who require a visa to enter Bulgaria should be aware that there is no possibility for a Visa-upon-arrival application. Therefore, all participants have to check the visa requirements for entering Bulgaria and apply on time consulting with the Bulgarian Embassy appointed for the respective country. The Organizing Committee will assist all visa appliers by issuing visa invitation letters, once the Accommodation booking is completed. Unfortunately, the OC cannot speed up visa applications or contact embassies on behalf of visa applicants.
